Subject: Invitation to Submit a Proposal for Participation as an External Associate of the Institute on the Project CultHeRit – "Identifying solutions for labor market imbalances in the cultural heritage sector in the Danube region by improving its accessibility to young professionals"

I am pleased to inform you that you are invited to take part in the [simplified procedure] for the above supply contract. The complete tender dossier includes:

A. Instructions to tenderers

We kindly ask you to submit an offer for participation, as an external associate of the Institute, in the project CultHeRit – "Identification of Solutions for Labour Market Imbalances in the Field of Cultural Heritage in the Danube Region by Improving Access for Young Professionals."

CultHeRit is an initiative of 13 institutions from 8 countries, co-financed by the Interreg Danube Region Programme. The aim of the project is to identify and test solutions to prevent the brain drain of young talents and professionals in the field of Cultural Heritage (CHIM).

Your tasks, to be completed by the end of Project (June 2026), include the following activities:

- -Preparation of periodic reports (every 6 months);
- -Definition of an aspirational employment model for cultural heritage institutions;
- -Monitoring the work of the Key Stakeholder Group (KSG);
- -Preparation of presentations for partner meetings;
- -Monitoring the labour market situation in the field of cultural heritage protection.

Reports shall be submitted on a semi-annual basis. The Institute reserves the right to request ad hoc reports if deemed necessary. Reports shall be submitted in both digital and hard copy formats, in Serbian or English.

Two contractors are required, with a total price of €15,000. The evaluation criteria are:

- CV
- -Offered price
- -Experience in the field of heritage protection (deliver a proof)
- -Experience working on EU projects (deliver a proof)
- -Level of education (deliver a proof)
